It may be noted that public display of Aadhaar Number of resident in such a manner is a violation of section 29(4) of the Aadhaar Act, 2016.

Further, financial information such as bank account details, Aadhaar Number which is also being used as a financial address, are sensitive personal data, the publishing of which is violations of the provisions of Information Technology Act, 2000 and the rules framed under thereunder. The violation constitutes an offense under,

- a) Section 37 of the Aadhaar Act, 2016(punishable with imprisonment for a term which may extend to three years or with a fine which may extend to ten thousand rupees or with both).
- b) Section 72 of the Information Technology Act, 2000(punishable with imprisonment of up to two years, a fine of up to Rs 100,000 or both).

For compliance of the same, it is requested to remove the file as mentioned above or mask the initial 08 digits of Aadhaar, immediately with a confirmation to this office.
