REPORT**


The report of Three Men Committee constituted in the A.G.M. dated 22.01.2017 was circulated among the members. All members unanimously accepted the same.

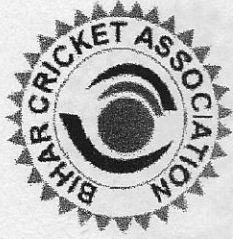
