DCA's are again requested to send the forms of each selected players along with copy of Aadhar Card as mandatory documents and any supporting govt. documents .

There shall be no relaxation of age on any ground whatsoever.

If any player of a district team are found over age, such player shall be banned from playing any match for three years & if three or more players of same district are found over aged, the said District shall be banned from playing any tournament for further one year and for each disqualified player the District has to pay a penalty of Rs. 10000/- per player.

It is also made clear that if any protest/doubt is made against any player(s), the medical test for age verification by BCA appointed doctors shall be done and opinion of the doctors shall be final irrespective of his/their age in Aadhar Card or any other supporting documents. The medical test shall be done at the expense of the player concerned/guardian.

ALL DOCUMENTS AND A FORWARDING BY Hony. SECRETARY OF THE DISTRICT SHOULD REACH TO BCA SECRETARY/ BCA CONVENOR WITH FIVE CLEAR DAYS BEFORE COMMENCEMENT OF THE TOURNAMENT, FAILING WHICH THE TEAMS SHOULD NOT BE ALLOWED TO PARTICIPATE.

THE PRESENT RE-IMBURSHMENT TO THE DISTRICT ASSOCIATION / UMPIRES / OBSERVERS / OFFICIALS / SCORERS IS NEGLIGIBLE IN COMPARISON TO THE ACTUAL EXPENCES THEY INCUR IN PARTICIPATING IN TOURNAMENTS : SUGGESTIONS ARE :

GROUND MAINTANANCES TO BE INCREASED TO Rs. 2000/- TO TURF-WICKETS/PER MATCH DAY WHEREAS Rs. 1400/- TO MATTING WICKETS.

LODGING ALLOWANCES TO STAGING ASSOCIATION FOR PLAYERS , UMPIRES, OBSERVER, OFFICIAL BE INCREASED FROM Rs. 2500/- TO Rs. 5000/- PER MATCH DAY WHERE AS FOR EXPENCES OF LUNCH/TEA FOR TEAMS ON MATCH DAYS BE INCREASED TO Rs. 5000/- PER MATCH DAY.

EXPENCES FOR THE BALLS CAN BE MINIMUM Rs. 1000/- PER BALL USED DURING A MATCH.

THE ALLOWANCES TO PLAYERS OF EACH PARTICIPATING TEAM SHOULD BE MINIMUM OF Rs. 300/- PER DAY.

THE JOURNEY EXPENCES TO THE TEAMS SHOULD BE MINIMUM Rs. 1500/- PE JOURNEY.
