PROCEEDINGS OF THE ANNUAL GENERAL MEETING OF BIHAR CRICKET ASSOCIATION DATED 29th OF SEPTEMBER, 2019

The Annual General Meeting of the Bihar Cricket Association, Patna was held today i.e. 29th September 2019 at 09:00 AM at Hotel Maurya, Patna (just before the Election of the office bearers of BCA scheduled today itself from 10:00 AM.) The meeting was presided over by Shree Gopal Bohra, the President BCA. Attendance: As per the proceeding register.

Agenda 1

Conformation of the proceeding of the last AGM held on 25th May 2019 at Hotel Abhilasha, Pawapuri, Nalanda.

The proceeding of the last meeting of General Body of the BCA held on 25th May, 2019 was read by the Honorable President before the house and the same were approved and confirmed by the house. Therefore, the President put his signature on the proceedings.

Agenda 2

The President spoke about the importance of the Election and accordingly the role & responsibilities of the voters and also requested the members to cast their votes to ensure a better and brighter future of Bihar Cricket.

Agenda 3

Other matters with the permission of the Chair.

Some members wanted to raise some issues to which the President allowed a few only as the election was to start soon.



Issue 1:

Mr. Gyaneshwar Gautam, the Hony. Secretary of East Champaran DCA raised the voice against the implementation of Justice Lodha Committee recommendations in District Associations and requested to rescind such decision the interest of the district association; several representatives of other district associations supported the move. After a brief discussion, no final conclusion was arrived at in respect of the issue.

Issue 2:

Shree Pravin Kumar, member of COM being the representative of District Association wanted to know the status of 13 District Associations and also sought to know whether the names of the office Bearers of these 13 District Associations are for the ongoing Election Process or for all future purposes.

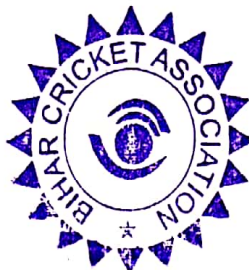
The voter list published by the outgoing Electoral Officer Mr HC Sirohi on 13th September 2019 for the ongoing process and the same has been adopted by the present Electoral Officer Mrs Meera Pandey as informed by the Hony. Secretary, now it is up to the house to take decision as to whether the list of the Office Bearers as published by the Electoral Officer shall remain effective for ongoing election purpose only. During the discussion it was raised by several attendees that list of the office bearers of some associations are incomplete hence these cannot be accepted for running the affairs of such associations. Therefore, the voter's list published by Mr. H.C.Sirohi on 13th of September, 2019 was unanimously considered by the house for the election purpose only.

Issue 3:

Mr Sunil Kumar Rana has raised the matter of Bhojpur DCA where the President of BCA had decided to conduct the Election afresh because the election was conducted in defiance of his order. After considering the case it was decided to direct the Bhojpur DCA to hold the election of its office bearers at the earliest.

Issue 4:

Further, Mr Ram Kumar, individual member raised the issue of taking away the voting right of individual members by Bihar Cricket Association on the pretext of implementation of Justice Lodha Committee Recommendations whereas in other state associations like Jharkhand Sate Cricket Association, individual members have voting right and called upon members to take decision in this regard so that the individual members may remain in the main stream. The House after hectic



discussion and deliberation arrived at the conclusion to grant voting right to individual members, subject to necessary amendment in the BCA Rules & Regulations and complete restriction over enrolment of new individual members.

Issue 5:

The appointment of Ombudsmen came up for discussion as disputes of several district Associations have not been resolved as yet. The Honorary Secretary informed the House that disputes in several district associations are still persisting which caused hampering the activities of associations and players are the worst sufferers. After discussion and deliberation the appointment of Ombudsman was felt to be most urgent. But since a new committee may be formed after the elections to be held today later, so the house deferred the matter for the next AGM to be held after the constitution of the new committee.

Issue 6:

It was raised by Mr Rabi Shankar Prasad Singh, Honorary Secretary, BCA, that final statements of accounts of BCA for the Financial Year 2018-19 has not been passed, hence such final statements of account need to be tabled for discussion and to pass, it was ruled by the Chair that presentation of statements of Accounts is not in the Agenda of today's General Body Meeting. However as resolved in the last AGM held on 25/05/2019, the matter may be taken up today and accordingly the house approved the Audited Statement of Accounts of BCA for the financial year 2018-19, accordingly.

Issue 7:

The Honorary Secretary sought to approve the decisions/resolutions adopted in the COM after the AGM held on 25th May 2019. The House resolved to approve resolutions adopted after 25th May 2019.









The meeting ended with a vote of thanks to the chair.
