(Nomination papers must be submitted in person or through duly authorized representative only).
 - 3. The scrutiny of the nomination papers will be done on 23.09,2019 itself in the office at Hotel Maurya, Durbar Hall, from 11 am 03 pm.
 - 4. Nominations can be withdrawn by the candidates from 11 AM to 01 PM on 24.09.2019 in writing, addressed to the undersigned and to be submitted in the camp office at Room No. 309, Hotel Maurya, South Gandhi Maidan, Patna-800001.
