

Notice

The voting on the five posts of BCA i.e. 1 President 2. Vice- President 3. Joint Secretary 4. Treasurer 5. District Representative is scheduled to commence on 29.09.2019. The Committee of Management BCA Patna called for a meeting on 02.09.2019 to adopt the Rules of Procedure of BCCI dt. 16.08.2019, after the approval of the Electoral Officer, BCA Patna. The Committee of Management, BCA Patna had adopted on 02.09.2019 the Rules of Procedure (Conduct of Elections to the post of BCCI Office Bearers) dated 16.08.2019

AS per clause 6 (a) of these "Rules of Procedure" the Electoral Officer shall cause arrangements to be made for voting by the representative of eligible members on the Election Day.

In view of the provisions as laid down in clause 6 (a) of the BCCI Rules of Procedure dated. 16.08.2019, it is clarified and ordered that only duly authorised Representative of the office bearers of DCA concerned, as reflected in the "Name of office bearers of full members of Bihar Cricket Association" as published on 13.09.2019 / 20.09.2019 will be allowed to vote for the posts of BCA. The voter must also be one the office bearers of the DCA concerned as reflected in the "Name of office bearers of full members of Bihar Cricket Associations" as published on 13.09.2019/ 20.09.2019 by the Electoral Officer BCA Patna. The authorised representative will come to vote with his original Aadhar card and Affidavit to ensure that their eligibility to vote conforms with the provisions of the Lodha Committee recommendations.
