ORDER

The schedule for conduct of elections to Bihar Cricket Association was published on 28-08-2022. The list of nominated candidates was caused to be published for the information of the concerned. In pursuance of item No.9 of the schedule, the scrutiny of the nomination papers is scheduled on today the 21-09-2022.

The scrutiny of nomination papers was taken up by the Electoral Authority, taking into consideration the instructions notified by this authority, for the information and strict compliance of the candidates filing the nominations.

The scrutiny commenced from sr.No.1 and 2 filed by shri Rakesh Kumar Tiwary for the post of President was found in order. As two nominations of a single candidate for one post are not maintainable, the nomination paper at serial No.2 is rejected.

Nomination at serial No.3. Ms. Hema Kumari Sinha for the post of President, Serial No.4 Shri Dilip Singh for the post of Vice President, serial No. 5 Shri Ashutosh Nandan Singh for the post of Treasurer, serial No.6 Shri Amit Kumar for the post of Secretary, serial No.7 Shri Om Prakash Jaiswal for the post of Councillor, serial No. 8 Shri Amarnath Dube for the post of President and nomination at serial No. 9 Ms. Priya Kumari were duly scrutinized.

On scrutiny, the nomination at serial No.3 of Ms. Hema Kumari Sinha and nomination at serial No.8 of Shri Amarnath Dube, are found to be in contravention of the instruction No.6 of "**Instructions to the candidates for**




