**ORDER dated 21.09.2025**

1. On 15.09.2025, Complaint Nos. 6, 7 & 8 were partly heard. The said complaints were directed to taken up for hearing at 6:30 pm today.
2. On 15.09.2025 an opportunity was given to the persons to file complaints who are aggrieved by their exclusion from the voters' list and those who are aggrieved by inclusion of ineligible voters in the voters' list, which were also directed to be taken up today.
3. Complaint Nos. 9 to 25 were filed after serving a copy on the Bihar Cricket Association. The email account of the ombudsman was blocked by Google today afternoon for undisclosed reasons due to which the aforesaid complaints were inaccessible.
