Heard Sri Rajesh Kumar Singh, Advocate for the Respondent Mr. Sanjay Kumar, Sri Navjot Yesu, Advocate for the Respondent No. 1 and 2 in E.O. 4 of 2020 and for petitioner in E.O.03 of 2020.

It has been submitted by Sri Navjot Yesu, Advocate on behalf of Respondent No. 1 and 2 in E.O. 4 of 2020 and for petitioner in E.O. 3 of 2020 that main relief in E.O. 03 of 2020 and also in E.O. 04 of 2020 are that the respondent Sri Sanjay Kumar be restrained from acting as Secretary of Bihar Cricket Association (BCA) and vide order passed in E.O. 01 of 2020 and E.O. 02 of 2020 on 15th day of May 2021 said respondent Sri Sanjay Kumar was held to be acting as Secretary of Bihar Cricket Association (BCA) having influenced Selectors hatched a conspiracy with them to include his son Sri Shivam S Kumar in fifteen players squad of Vijay Hazare Trophy in the year 2019 and on that finding he (said Sri Sanjay Kumar) was held to be guilty of conflict of interest and for that he was directed to be removed from the post of Secretary, BCA and debarred from taking his involvement with the game of cricket for a period of one year from that day i.e., 15.05.2021 and said order has taken effect and the aforesaid two cases E.O. 03 of 2020 and E.O. 04 of 2020 would be disposed in view of the aforesaid finding and order passed on 15.05.2021 in E.O. 1 of 2020 and E.O. 2 of 2020 to which Sri Rajesh Kumar Singh, Advocate for respondent Sanjay Kumar conceded.

In view of the aforesaid, as respondent Sri Sanjay Kumar has been removed from the post of Secretary, BCA and debarred from being involved himself in the game of cricket for one year commencing from 15.05.2021, as stated above, said order dated
