Both the cases have been brought alleging that earlier one case bearing E.O. 01-02 of 2020 was filed by the President of Jehanabad Cricket Association regarding illegal act of the then Secretary Mr. Sanjay Kumar in collusion with the then Chairman Senior Selection Committee Mr. Zisan-Ul-Yaquin and other members (namely Mr. Sanjeev Kumar, D. Chakravorty) of said Selection Committee and also another complaint for the same allegation by the then Secretary, Arwal DCA and after amalgamation of both aforesaid Complaints, both the said complaints were heard analogously and lastly on 15.05.2021, Ethics Officer of BCA held said Mr. Sanjay Kumar, Zisan-Ul-Yaquin, Sanjeev Kumar and D.Chakravorty guilty of conflict of interest and the said order of the Ethics Officer was later on confirmed by the BCA in its General Body Meeting.

It has been further averred in both the present complaints that as per Rule 4(5) of the Bihar Cricket Association "Any Administrator, Player, Match official, team Official, Selector or other individual associated with the B.C.A on being found guilty and expelled by the BCA shall forfeit all their rights and privilege. He or she shall not in future be entitled to hold any position or office or be admitted in any committee or any role on the BCA".

Further it is stated in the complaints that Mr. Zisan-Ul-Yaquin the then Chairman, Senior Selection Committee have not challenged the order dated 15.05.2021 to any Court of Law, meaning thereby he has accepted his guilt. He never submitted any documents regarding set-aside/stay the order dated 15.05.2021. Further it is stated in the aforesaid complaints that BCA has announced the Ranji Trophy team on 08.02.2022 and surprising enough that Mr. Zisan-Ul-Yaquin has been nominated for Coach of such type of prestigious team, without any authority and it has been claimed that under the facts and circumstances placed above it is a fit case in which Mr. Zisan-Ul-Yaquin must be restrained from working as Coach of Bihar Ranji Trophy team and BCA may be directed to not repeat the said mistake in future; and on the aforesaid premises it has been prayed that Zisan-Ul-Yaquin be restrained from working as a Coach of Bihar Ranji Trophy team 2021-2022 with further prayer order to pass any other order or orders as found fit and proper.

The copy of the order dated 15.05.2021 passed in EO/01-02/ of 2020, in which Mr. Zisan-Ul-Yaquin has been held guilty, has been supplemented with the main petition in each of the aforesaid present both cases; from which it is evident that said Mr. Zisan-Ul-Yaquin was held guilty as stated in the aforesaid both cases and therefore, it prim-facie appears that as per Rule 45(5) of the BCA Rules and Regulations he is not fit person to act as Coach of Bihar Ranji Trophy Team 2021-22 and therefore he is restrained to act as such Coach till further order which would be passed after hearing the Opposite Parties on the aforesaid matter.
