UPON hearing the counsel the Court made the following
O R D E R

1. We appoint Shri Prabhas Bajaj, learned counsel as an Advocate on Record to assist the learned Amicus Curiae in this matter.
2. The Registry of this Court is directed to supply hard/soft copies of all the pending applications to learned Amicus Curiae so that the learned Amicus Curiae can examine the same.
3. List this matter along with applications after four weeks.

I.A. NO.11359 OF 2023

1. The application has been moved by the Delhi and District Cricket Association (DDCA) seeking approval of its draft Constitution to bring it in conformity with the constitution of the BCCI, as approved by this Court.

2. A copy of the IA, together with the draft Constitution, shall be submitted to the BCCI unless it has already been submitted.
3. The BCCI shall furnish its report on whether the draft constitution is in compliance and shall forward its report to the Amicus Curiae for placing before this Court. This exercise shall be completed on or before 15 February 2024.
4. I.A. is accordingly disposed of.

I.A. NO.223743 & 223744 OF 2023

1. These applications would be considered after the Report is received from the Board of Control for Cricket in India (BCCI) in I.A. No.11359 of 2023.

I.A. NOS.162269 & 162271 OF 2024

1. Shri A.N.S. Nadkarni, learned senior counsel appearing for the Bihar Cricket Association, with a prayer to allow the present application and grant approval to the amendments of the Constitution of Bihar Cricket Association.
2. The amendments sought for have been examined by the BCCI as well as by Shri Maninder Singh, learned Amicus Curiae.
3. Learned Amicus Curiae has submitted its report dated 18.07.2023.
4. Learned Amicus Curiae, after considering the report of the BCCI has made certain suggestions to be incorporated in the Constitution of the Bihar Cricket Association.
5. Shri Nadkarni, learned senior counsel, states that the applicant would incorporate the said suggestions, as given by the learned Amicus Curiae.
6. In that view of the mater, we are inclined to allow I.A. No.162269 of 2024. Ordered accordingly.
7. The approval to the amendment of the Constitution of Bihar Cricket Association is granted along with the suggestions to be incorporated therein as per the Report of the learned Amicus

Curiae.

8. List after eight weeks to report compliance.
9. Application seeking exemption from filing official translation is disposed of.
