1. Arguments were advanced by the Learned Counsel for Complainants and the Bihar Cricket Association in Complaint Nos. 15, 33, 39, 40 & 41 of 2025. Order Reserved.
2. A clarification was sought by the Learned Senior Counsel for BCA as to whether BCA may proceed with registration of players on the BCCI ODMS Platform for the upcoming tournaments. Even in the Order of 07.10.2025, the Ombudsman did not prevent BCA to

register players on the BCCI ODMS Platform. BCA was directed to postpone the final selection to 10.09.2025 as a hearing was scheduled on 09.09.2025. BCA is permitted to proceed with the registration of players on the BCCI ODMS Platform.
