#### ORDER

- 1. On 26.09.2025, the Bihar Cricket Association was directed to file its counter in all the pending complaints within a period of four (4) weeks. The Complainants were directed to implead the affected parties within two (2) weeks. The impleaded parties was given an opportunity to file their replies. On 27.10.2025, miscellaneous application nos. 1930-1931/2025 in SLP(C) Nos. 21132-21133/2025 were listed for hearing before the Supreme Court of India. The said applications were directed to be taken up on 15.12.2025. In the meanwhile, the Ombudsman was permitted to submit his report regarding the legality and validity of electoral rolls prepared and in the transparency of elections conducted to the executive committee of Bihar Cricket Association on 28.09.2025.
- 2. On 04.11.2025, all parties were informed that the complaints related to the election held on 28.09.2025 would be taken up for hearing on 22.11.2025 and 23.11.2025.
- The Ld. Counsel appearing for Complainants and the District Cricket Associations for the districts of Jehanabad (Complaint Nos. 8, 13, 18 & 23), Nalanda (Complaint Nos. 9 & 27) and Madhubani

(Complaint No. 30) were heard between 5 pm to 7 pm on 22.11.2025 and 23.11.2025. The Ld. Counsel for BCA shall be heard on the aforementioned complaints on 03.12.2025 at 5 pm. In the meanwhile, the District Cricket Associations heard thus far are permitted to file a written note of submission along with documents, if any, after serving copies to the Ld. Counsel of the Complainants.
